

**Form of
Eligible Participation Agreement**

This Eligible Participation Agreement, which will be effective as of the date T-Mobile signs below, is by and between T-Mobile USA, Inc. ("**T-Mobile**") and _____ ("**Eligible Participant**"). Reference is made to that the certain Main Corporate Services Agreement between [**Full Legal Name of Customer signing MCSA**] (for purposes of this Eligible Participation Agreement, "**MCSA Signing Party**") and T-Mobile, effective _____ ("**Agreement**").

- 1. Rate Plans and Discounts.** Eligible Participant will receive the Rate Plans and discounts set forth in the Pricing exhibit attached to the Agreement. Eligible Participant agrees that T-Mobile and MCSA Signing Party may modify the Rate Plans and discounts under the Agreement, which will automatically modify the Rate Plans and discounts applicable to this Eligible Participation Agreement. T-Mobile will invoice Eligible Participant separately from MCSA Signing Party and Eligible Participant is responsible for its own Charges.
- 2. T-Mobile for Business ("TfB") Terms and Conditions.** The TfB Terms and Conditions, the TfB Master Account Wireless Services Product Annex, the Information Security exhibit, and the applicable T-Mobile Services and Product annexes and Third-Party Solutions terms and conditions, as posted at <https://www.t-mobile.com/business/terms-and-conditions> (the "**TfB Terms and Conditions Website**"), as may be updated from time-to-time, are incorporated into this Eligible Participation Agreement and apply to all Services, Products, and Third-Party Solutions purchased under this Eligible Participation Agreement. Capitalized terms used in this Eligible Participation Agreement that are not otherwise defined will have the meanings assigned to them in the Agreement, the TfB Terms and Conditions, or a document posted to the TfB Terms and Conditions Website.
- 3. Confidential Information.** This Eligible Participation Agreement and any information concerning its terms and conditions are T-Mobile's Confidential Information and are governed by the Confidentiality provisions of the TfB Terms and Conditions. Notwithstanding the foregoing, Eligible Participant consents to T-Mobile providing MCSA Signing Party with access to Eligible Participant's invoices and other aggregate data concerning Eligible Participant's number of lines, Monthly Recurring Charges, and other purchases, and in no event will T-Mobile providing such access be deemed a breach of its confidentiality obligations.
- 4. Co-Terminous.** Unless terminated earlier, this Eligible Participation Agreement will be co-terminous with the Agreement.
